# UNITED NATIONS CONVENTION ON CONTRACTS FOR THE INTERNATIONAL SALE OF GOODS CONCLUDED AT VIENNA ON 11 APRIL 1980

### RATIFICATION BY AUSTRIA, FINLAND AND SWEDEN ACCESSION BY MEXICO

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The following States have deposited with the Secretary-General their instrument of ratification or accession to the above-mentioned Convention on the dates indicated hereinafter:

The instruments of ratification by the Governments of Finland and Sweden contain the following declarations:

#### **FINLAND**

(Original: English)

"1. With reference to Article 92, Finland will not be bound by Part II of this Convention (Formation of the Contract).

With reference to Article 94, in respect of Sweden in accordance with paragraph (1) and otherwise in accordance with paragraph (2) the Convention will not apply to contracts of sale where the parties have their places of business in Finland, Sweden, Denmark, Iceland or Norway."

#### **SWEDEN**

(Original: English)

- "1. With reference to Article 92, Sweden will not be bound by Part II of this Convention (Formation of the Contract).
- 2. With reference to Article 94, in respect of Finland in accordance with paragraph (1) and otherwise in accordance with paragraph (2) the Convention will not apply to contracts of sale where the parties have their places of business in Sweden, Finland, Denmark, Iceland or Norway."

In accordance with article 99 (2), the Convention will enter into force for Austria, Finland, Mexico and Sweden on 1 January 1989, i.e. the first day of the month following the expiration of twelve months after the date of the deposit of the said instruments.
